to the international academic conference "Bratislava Legal Forum 2019"

Comenius University in Bratislava, Faculty of Law, in the cooperation with the Supreme Court of the Slovak Republic and the Judicial Council of the Slovak Republic would hereby like to invite you to the fifth year of the international academic conference "Bratislava Legal Forum 2019" which will be held on 14th and 15th February 2019 under the auspices of JUDr. Daniela Švecová, President of the Supreme Court of the Slovak Republic and JUDr. Lenka Praženková, President of the Judicial Council of the Slovak Republic.

The primary topic of the plenary session held at the conference is "Independence and ethical dimension of the judicial power exercise".

The aim of the conference is to provide a discussion platform to the judges and other legal practitioners as well as to the academic community. The conference is, in accordance with the aforementioned aim, divided into a plenary session and parallel discussions conducted in topicbased sections with the primary focus on the current issues and challenges faced by judiciary.

VENUE: Faculty of Law at Comenius University in Bratislava (Šafárik Square No. 6, Bratislava)

LANGUAGE: Slovak, Czech, English (plenary session and selected sections)

DEADLINE FOR APPLICATIONS: 21st January 2019, including the submission of the title and abstract of the paper. This information will be made public on the website of the conference from the time of the registration.

The registration may only be carried out via online registration system available on the website https://bpf2019.flaw.uniba.sk/index.php/en/.

DEADLINE FOR SUBMITTING A COMPLETE PAPER: 28th February 2019. Formal requirements of the paper and instructions for its processing will published on the conference web site. In the event that a person does not eventually participate in the conference or fails to submit his/her paper, he/she shall have no right to recover the conference fee.

CONFERENCE FEE: The fee of EUR 80 may be paid solely by means of a wire transfer based on an e-invoice that will be issued upon the registration for the conference.

ACCOMODATION: participants shall arrange the accommodation themselves and pay for it individually

COLLECTION OF PAPERS: Reviewed collection of papers with an ISBN No. assigned to it will be produced in an electronic (CD) form and will be permanently accessible on the website of the conference and the website of the Faculty of Law at CU.
