B. Criteria for admission	1. Additional conditions of admission	a) Completion of a bachelor's or master's study programme in the field of law in the Slovak Republic, or completion of a master's study programme in the field of law in the programme of law and legal sciences in the Czech Republic, or completion of a bachelor's or master's study programme in the field of law in a country other than the Slovak Republic or the Czech Republic based on a decision on the equivalence of documents, and b) Basic knowledge in the field of European law and international law, and c) Language skills and proficiency in the English language
	2. Date of the admission procedure	September 2023
	3. Evaluation of the admission procedure	50% evaluation of the entrance exam on the basics of European law and international law 50% evaluation of the applicant's language skills
	4. Content of the entrance exam	a) The content of the knowledge verification (entrance exam) consists of the basics of European law and international law. Verification of knowledge in the specified range takes place in the form of a written knowledge test.

		b) The language skills of study applicants are demonstrated by presenting a language certificate at the level of at least B2 according to the European Reference Framework. For the purpose of verifying the applicant's language skills, language certificates issued by selected institutions are accepted in accordance with the Annex to the Decree of the Ministry of Education of the Slovak Republic no. 319/2008 Coll. If the applicant does not have a language certificate at the level of at least B2, his language ability is checked in the form of a written language test.

	6. Form of the entrance exam	Written exam.
	7. Evaluation criteria	The applicant can achieve a maximum number of 300 points, of which 150 points for the written knowledge test and 150 points for language skills.

C. Application	1. Application deadline	Until 31.08.2023 The dean can extend the application deadline.
	2. Application submission	The applicant fills out an electronic application for studies (e-prihlaska.uniba.sk). The CV, motivation letter and documents proving knowledge of the English language are submitted electronically. Documents on the completion of a bachelor's degree and Decision on the recognition of the equivalence of a document on education, or The confirmation of the equivalence of the educational document issued by a foreign school and the transcript of the results of studies at the 1st stage of university studies are translated in the form of certified photocopies in person, resp. they are sent by mail to the address of the faculty.

Application attachments	<ul style="list-style-type: none"> - CV (in English), - Letter of motivation (in English), - Certified photocopies of documents on completion of a bachelor's degree (e.g. university diploma, diploma supplement, state examination certificate), - Documents proving knowledge of the English language at least at B2 level (e.g. IELTS – min. 5.5, ESOL – min. FCE (Grade C), graduation exam certificate, state language exam certificate), - Study applicants from EU member states and Slovak study applicants who studied at a foreign university shall submit a Decision on the recognition of the equivalence of the educational document, or Confirmation of the equivalence of the educational document issued by a foreign school, these conditions do not apply to citizens of the Czech Republic, - Statement of results from studies at the 1st stage of university studies. For students who have completed the 1st stage of university studies in a given academic year at PraF UK, the faculty will provide transcripts of their study results free of charge. <p>A medical certificate of the applicant's eligibility for studies is not required.</p> <p>If the payment of the fee for the admission procedure is identified in accordance with point D.2, it is not necessary to submit the proof of payment of the fee.</p>

	4. Procedure for incomplete application	The applicant is invited to complete the application form and its attachments by e-mail; unless the applicant completes the application, a decision will be made based on the submitted data and documents, if possible, otherwise the application will be rejected. If the application is rejected due to its incompleteness, the fee paid for the admission procedure is not refunded.
	5. Note	If the admission fee is not paid, the application will not be considered.
