



Information according to Art. 11 par. 4 of the Study Regulations Comenius University in Bratislava, Faculty of Law (for groups all groups of students)

- I. **Semester / academic year:** Summer semester, a.y. 2023/2024
- II. **Study program / degree / form:** law/I. degree and II. degree /daily
- III. **Course title:** **Legal aspects of climate change**
- IV. **Language:** **English**
- V. **The extent of compulsory participation in educational activities**
Students are informed that the conditions of participation in individual forms of teaching and the replacement of non-participation are covered by the Study Regulations.
Transfers between seminar groups are subject to the consent of the lecturer.
They are only allowed in exceptional cases, as students create their own schedule and it is necessary to ensure that the seminar groups are as balanced as possible in terms of the number of students.
- VI. **Conditions under which a student can make up for not attending seminars:**
Substitute performance for non-participation in the seminar over the number of absences stipulated by the Study Regulations is determined by the lecturer individually, taking into account the number and reasons for absences, usually in the form of a paper on a topic agreed with the student.
- VII. **Concretization of the method of evaluation of study results, including concretization of the method and conditions of passing the corrective terms of the continuous evaluation:**
The evaluation consists of two parts:

A. Essay

At the end of the semester, students are given the opportunity to choose one of the specified topics (or have the opportunity to design their own topic) and they should





write an essay on a specified range (usually 15 to 20 thousand characters). The range of topics is determined following the theses of lectures and seminars.

Students can get a maximum of 50 points = 50 percent of the total evaluation for the written and submitted essay.

B. Semester work (paper)

The second part of the course evaluation is an exam in the form of a written semester work (hereinafter also referred to as an "exam"). Students can get a maximum of 50 points = 50 percent of the total evaluation. Students register for the exam through the AIS system, the date chosen for them. The exam consists of open-ended questions aimed at verifying the ability to master the curriculum, and in particular the ability to work with sources of law in a formal sense and the ability to apply theoretical knowledge to positive law or, conversely, to abstract theoretical knowledge from positive law. When preparing the paper, students are entitled to use the texts of sources of law in a formal sense, as well as professional literature, notes, printed PowerPoint presentations and etc. (so-called "open books" system).

VIII. The Final evaluation

The student can get a total of 100 points = 100 percent of the evaluation. The final evaluation (grade) will be determined as follows:

- A** = 91–100 %
- B** = 81 – 90 %
- C** = 73 – 80 %
- D** = 66 – 72 %
- E** = 60 – 65 %
- Fx** = 0 – 60 %

IX. Information whether the condition for taking the exam is the achievement of the prescribed level of continuous assessment or the prescribed scope of compulsory participation in educational activities

If the student does not replace the fourth (and next) non-participation in the seminars or does not prove a sufficient degree of self-study during the examination the student is not evaluated from the subject and cannot take the exam (it is unclassified - "X").





X. Additional information

- Teaching is not strictly divided into a part of a lecture and a part of a seminar, but takes place in a hybrid form, where emphasis is placed on involving students in the discussion.
- The subject will be taught in English language on Thursday from 12:15 to 14:25 in the room Súdna sieň (the Court room – room no. 7 in the old building).
- The course will have its own team in MS TEAMS, where students will be added after the first seminar.
- It is necessary to prepare for seminars and have materials according to the teacher's guidelines.
