- I. Semester/academic year: *from: winter semester, 2023/2024*
- II. Study program/degree/form: *Management and Law/master/full-time*
- III. Course title: *Comparative Constitutional Law and Criminal Law, for all lecturers*
- IV. The person with the main responsibility for the quality of the subject, its development and the unification of the approaches of individual teachers:
doc. JUDr. Lívia Trellová, PhD.
- V. Extent of compulsory participation in educational activities:
a) *Maximum of 3 absences.*
- VI. Conditions under which a student can substitute for non-participation in seminars:
a) *Acceptable one more absence.*
b) *In case of more than 4 absences, the student will not be admitted to the evaluation and will be classified "X" (unclassified). Student will have to repeat the subject within the next teaching period.*
c) *Conditions for replacement of 4th – solving of a case on absented topics.*
- VII. Concretization of the method of evaluation of study results, including concretization of the method and conditions of passing the corrective terms of the continuous evaluation:
a) *Method of evaluation - continuous evaluation (100%) – 20 % points active participation in the seminar discussion; 40 % points oral presentation of the student's research project on the topic of constitutional law; 40 % points oral presentation of the student's research project on the topic of criminal law.*
b) *Concretization of the method and conditions of passing the corrective terms of the continuous evaluation – as instructed by the teacher.*
- VIII. Dates of the ongoing evaluation, thematic areas of individual dates of the ongoing evaluation:
a) *Term of continuous evaluation and topics – as instructed by the teacher.*





- IX. Information on alternative possibilities of meeting the conditions of the interim evaluation, which, however, are not the overall corrective date of the interim evaluation according to Art. 13 par. 4 of the Study Regulations of the Faculty:
- a) *Substitute continuous assessment – Alternative dates for the subject part of the continuous assessment will be set only for students who did not attend the regular date of the subject part of the continuous assessment and prove that they could not attend this form of examination for objective and compelling reasons.*
- X. Information whether the condition for taking the examination is the achievement of the prescribed level of continuous assessment or the prescribed scope of compulsory participation in educational activities:
- a) *Assessment is only by means of continuous assessment, and the student must obtain at least 60% of the continuous assessment, otherwise the student is not classified in the course. Passing the continuous assessment is subject to the completion of the required attendance at the seminars.*
