| Learning outcomes: The course acquaints students with basic elements of Roman public law. It concentrates on a thorough analysis of Roman state law, Roman administration, and partly Roman criminal law as well. The aim is to provide students with a stable base that would enable them to further explore scientifically the instituted of Roman private law on in their mutual connection. Acquiring knowledge about institutes of Roman state and public law also helps the students to orient themselves in Roma history in a more qualified manner, and to better understand the periodization of Roman private law. After finishing the course, the students are able to scientifically research the institutes of Roman public law. | |
| Class syllabus: 1. Roman kingdom, constitutional and administrative characteristic, analysis of legal and non-legal sources; 2. Creation of the Roman Republic, reasons for the expulsion of Roman kings; 3. the term of a Roman magistrate, qualification of execution of magistracy (cursus honorum), jurisdictions of magistrate, insignia and auxiliary personnel of a magistrate; 4. Basic constitutional principles of the Roman Republic and their gradual modification; 5. Legal enshrinement of a consulate and the office of a dictator in the period of the Roman Republic; 6. Competencies of the tribune of the people, censor, and praetor in the time of the Roman Republic; 7. Competencies of aediles and a questor, analysis of other extraordinary offices (e.g. decemvirate); 8. The creation of a principate from the legal perspective, constitutional characterization of early empire; 9. Legal status and jurisdiction of the Roman emperor in the early period; | |

10. Administration of Rome during the principate;
11. Constitutional and administrative characterization of dominate;
12. Constitutional and administrative organization of the Eastern Roman Empire in the time of Justinian;
13. Roman criminal law - general characteristics, basic principles, and philosophy;
14. Prosecution of Christians in the Roman Empire and changes in public law after the acceptance of Christianity.

| Learning outcomes: The course aims to acquaint the students with chosen scientific issues of Roman private law, as well as deepen their previous knowledge of specific legal institutes, and inspire and move them towards individual solutions to presented scientific questions, from analysis of certain cases preserved in the fragments of Roman lawyers to the problem of exegesis of certain legal source and verifying its authenticity and relevance. The aim is to offer the students a platform for their own research within legal Romanistics while acquainting them with the newest trends and developments in the field of Roman law. | |

Work with Justinian’s codification, citing, technique of working with interpolations, their practical use, and interpolation controversy in contemporary Roman law; 3. Ius Honorarium: praetor’s jurisdiction as a factor moderating the strictness and injustice of civil law, naturalis ratio; 5. Law of persons: the legal status of nasciturus, curator ventris, and views on abortion in Roman law; 6. Family law: the prohibition of gift-giving between marital partners in the context of the controversy between Ulp. D. 24, 1, 3, 12-13 and Afr. D. 46, 3, 28, 1; 7. | Learning outcomes: A student acquires orientation in the sources of Roman law concerning the theme of Roman family law. special attention is dedicated to the reading and interpretation of texts from the period of Justinian codification. The aims of the course are not limited just to getting acquainted with the texts of the mentioned collections but include the confrontation of students with various opinions and their interpretation, realization of systematic interpretation, and at last contemplating specifically presented cases and their solutions. | |

General introduction to Roman law: reading and interpretation of texts on agnate family and cognate family (status sui iuris, alieni iuris – title six of the first book of the Digest, Institutes of Gaius 1, 48-50 and title eight of the first book of the Institutes of Justinian – title six of the third book of the Institutes of Justinian); 2.
